Subject: Establishes requirements for multi-parcel auctions

State & Local Fiscal Highlights

- The Department of Agriculture will not incur any new costs for adding the multi-parcel auction format to the list of auction formats it regulates under current law. The Department currently oversees approximately 3,200 licensed auctioneers, auction apprentices, and auction firms statewide.
- The bill makes changes to foreclosure procedures. It appears that any increase in administrative work for county sheriffs to deliver the written statement of appraisal costs to the clerk of courts will be minimal and handled utilizing existing staff and resources.

Detailed Fiscal Analysis

Multi-parcel auctions

The bill establishes new requirements concerning multi-parcel auctions and has no direct fiscal effect on the state or political subdivisions. Current law generally governs three types of auctions – absolute, reserve, and estate auctions – which are regulated by the Department of Agriculture (AGR). The bill subjects an additional and commonly used type of auction – the multi-parcel auction format – to regulation by AGR. A multi-parcel auction is any auction of real or personal property in which multiple parcels or lots are offered for sale in various amalgamations, including as individual parcels or lots, combinations of parcels or lots, and all parcels or lots as a whole. Theoretically, bidding for various combinations under the multi-parcel auction format allows the seller to gain the highest possible price for the acreage being auctioned. Under current law, a person who wishes to act as an auctioneer or auction firm must obtain a license from AGR. Auctioneers are required to renew their license biennially, which includes a fee of \$200. The license fee for auctioneer firms is \$100 and is renewed annually. Both fees are deposited into the Auctioneer Fund (Fund 5B80). In FY 2017, Fund 5B80 collected \$291,500 in revenue. Currently, there are approximately

3,200 licensed auctioneers, apprentice auctioneers, and auction businesses in the state. One full-time employee works under the Auctioneer Program.

Foreclosures

Regarding judicial or execution sale of real estate, the bill clarifies certain timelines for online sales, and requires a sheriff to deliver a written statement of an appraisal's costs to the clerk of courts in certain cases. It appears that any increase in administrative work for county sheriffs to deliver the written statement to the clerk of courts will be minimal and handled utilizing existing staff and resources.
