#### **SUMMARY**

- Creates the "Dolly Parton Imagination Library" license plate.
- Designates multiple highways, interchanges, and an overpass.

### **DETAILED ANALYSIS**

License Plate	<b>Dolly Parton's Imagination Library</b> license plate, which must display an appropriate logo and words selected by the representatives of Dolly Parton's Imagination Library and approved by the Registrar of Motor Vehicles. <sup>1</sup>
Recipients	Available to all applicants.
Eligible Vehicles	Any passenger car, noncommercial motor vehicle, recreational vehicle, or other vehicle approved by the Registrar.
Contribution; Additional BMV Fee; Use of Contribution	\$25 required contribution. \$10 additional administrative BMV fee.  Contributions must be paid to Dolly Parton's Imagination Library of Ohio. The Library must use the money for operational costs, including the distribution of books. <sup>2</sup>

Requirements for Issuance	<ol> <li>Submission of an application;</li> <li>Payment of the regular license tax, any local tax, contribution, administrative fee, any special reserved license plate fee if necessary; and</li> </ol>	
	3. Compliance with all other relevant laws relating to motor vehicle registration.	
Combined with Special Reserved License Plate	May be combined with a special reserved license plate provided in current law.	
Special provisions	These specialty license plates are exempt from the following standard procedures:	
	1. The requirement that the Registrar receive written statements from at least 150 people that they intend to apply for and obtain the license plates before the Registrar provides for the issuance of those license plates; and	
	2. The requirement that the license plates display county identification stickers that use a number or name to indicate the county of registration. <sup>3</sup>	

## Highway and bridge designations

The bill designates the following highways, interchanges, and one overpass. It authorizes the Director of Transportation to erect suitable markers along the highways, interchanges, and the overpass indicating their names.

"PFC John Wayne Richard Memorial Highway" <sup>4</sup>	State Route (S.R.) 47 between McGreevey Road and Long Road, in Darke County	PFC John Wayne Richard served in the United States Army in South Vietnam during the Vietnam War. He was killed while fighting communist forces on May 21, 1969.
"John P. Lennon Memorial Highway" <sup>5</sup>	S.R. 87 between Bundysburg Road and Madison Road, in Geauga County	John P. Lennon was the President of Abbott Valve and Fitting, Co. He was an avid philanthropist and supporter of local police and fire departments – having

"CPL David James Amheiser Memorial Highway" <sup>6</sup>	S.R. 421 between United States Route (U.S.R.) 42 and Lodi Road, in Medina County	CPL David James Amheiser served in the U.S. Army during the Vietnam War. He was killed in action by communist forces on August 29, 1970.
"Deputy Sheriff Daniel Kin Memorial Highway" <sup>7</sup>	S.R. 53 between Township Road 11 to County Road 5, in Wyandot County	During his career in law enforcement, Deputy Sheriff Daniel Kin served at the Carey Police Department, the Seneca County Sheriff's Office, and the Wyandot County Sheriff's Office. While serving as a Deputy Sheriff in Wyandot County, Deputy Sheriff Kin's vehicle was struck by a pickup truck while he was transporting a prisoner. He died on December 15, 2022, from his injuries.
"Marshal Teddy Ray Holcomb Memorial Highway" <sup>8</sup>	S.R. 13 between S.R. 78 and S.R. 329, in Athens County	Marshal Teddy Ray Holcomb was a U.S. Army and Ohio National Guard veteran. He served with the Trimble Village Police Department and had previously served with the Nelsonville Police Department. He died on October 27, 1976, when he

"Chief Ronald A. Brown Memorial Highway" <sup>9</sup>	S.R. 16 between West Carlisle Road and Old Riley Road, in Muskingum County	Chief Ronald A. Brown had over 40 years of law enforcement experience with different agencies before retiring from the Clinton Township Police Department. He died on March 6, 2021, after battling cancer.
"Cpl. Robert Dockstader Memorial Highway" <sup>10</sup>	S.R. 2 between mile marker 117 and mile marker 122, in Ottawa County	Cpl Robert Dockstader passed away on January 27, 2023. He served in the U.S. Marine Corps and completed two separate tours of duty, including a tour in Iraq in 2005 during the Iraq War.
"Keith G. Earley Memorial Interchange" <sup>11</sup>	The interchange of I-475 and Dorr Street, in Lucas County	Keith G. Early was the Lucas County engineer from 2000 to 2019. During his career, Mr. Early oversaw numerous infrastructure improvements in Lucas County, including major highway interchanges, underpasses, roundabouts, and landscape improvements. He died on December 16, 2021.
"Marigene Valiquette Memorial Highway" <sup>12</sup>	I-75 between U.S.R. 24 at mile marker 203 and U.S.R. 24 at mile marker 206, in Lucas County	Marigene Valiquette was a member of the General Assembly for 24 consecutive years. She first served in the House of Representatives, beginning in 1963. She then served in the Senate from

"SSG Jack W. Coy Memorial Highway" <sup>13</sup>	I-280 between Navarre Avenue and Front Street, in Lucas County	SSG Jack W. Coy served in the U.S. Army Air Corps during World War II. He was killed in action on February 24, 1944, when his plane was shot down over Germany.
"CPT Louis John Speidel Memorial Highway" <sup>14</sup>	S.R. 28 between Castleberry Court and the Happy Hallow Road Overpass, in Clermont County	CPT Speidel served in the United States Army as a helicopter pilot. On April 23, 1971, his helicopter was shot down by communist forces during a mission in South Vietnam where he sustained serious injuries. Captain Speidel died on June 25, 1971.
"Marjorie Whiteman Memorial Highway" <sup>15</sup>	S.R. 109 between County Roads V and S, in Henry County	Marjorie Whiteman was a legal scholar, widely known for authoring the Digest of International Law. She also served as an advisor to former First Lady Eleanor Roosevelt and had a distinguished career with the U.S. State Department. She was inducted into the Ohio Women's Hall of Fame in 1979.

"William 'Bill' Burgett Memorial Highway" <sup>17</sup>	S.R. 13 between the intersection of Lexington Road and Beckley Road in Knox County	William "Bill" Burgett founded Kokosing Construction Company and was president of the Ohio Contractors Association and the National Utility Contractors Association. He died on November 26, 2015.
"Caitlin Renee Preston Memorial Highway" <sup>18</sup>	S.R. 72 between U.S.R. 42 and Clifton Road in Greene County	Caitlin Renee Preston passed away unexpectedly on May 28, 2019, as the result of an automobile accident. She was 18 and had recently graduated from Kenton Ridge High School.
"Clarence 'Sonny' Smith, Jr. Memorial Highway" <sup>19</sup>	S.R. 7 between Washington Boulevard and Western Reserve Road, in Mahoning County	Clarence "Sonny" Smith, Jr. was a prominent businessman in Youngstown who was active in many philanthropic causes, including donating his family's gemstone collection to the Youngstown State University's Geology Department. He died on April 13, 2021.

The Family owns Arrow International, a multinational manufacturer of charitable and social gaming products.
"Ronald 'Bumpy' Rhoades Memorial Highway" <sup>22</sup>	S.R. 203 between Penry Road and Norton Road, in Delaware County	Ronald Rhoades founded and operated Rhoades Subsurface Farm Drainage and was a former president of the Ohio Land Improvement Contractors of America. Ronald Rhoades passed away on October 1, 2020.
"Tuscarawas Valley Memorial Highway" <sup>23</sup>	I-70 in Etna Township in Licking County

"Al Oliver Highway" <sup>26</sup>	S.R. 125 between Rocky Fork Road and U.S.R. 52, in Scioto County	Al Oliver was born in Portsmouth, Ohio. He was an outfielder and first baseman for various Major League Baseball teams from 1968 to 1985, including the 1971 Pittsburgh Pirates World Series champion team.

"Lucille K. Wheat Memorial Highway" <sup>28</sup>	S.R. 41 between North Ridge Avenue and S.R. 202, in Miami County	Lucille K. Wheat was a real estate broker and civil rights activist and a life-long resident of the city of Troy. As a result of her passion for civil rights, she held numerous positions in civic associations, including the Troy Council of Churches, the National Association for the Advancement of Colored People (NAACP), the Troy
