**STATEMENT OF THE REASONS FOR THE VETO OF ITEMS IN AMENDED  
SUBSTITUTE HOUSE BILL 493**

**DECEMBER 13, 2016**

Pursuant to Article II, Section 16 of the Ohio Constitution, which states that the Governor may disapprove any items in a bill making an appropriation of money, I hereby disapprove the following items contained in Amended Substitute House Bill 493 and set forth below the reasons for so doing. The text I am disapproving is identified in this message by reference to the corresponding page and boxed text of the bill.

**ITEM NUMBER 1**

### **Prohibition of Abortion at Certain Stage of Development**

As governor I have worked hard to strengthen Ohio’s protections for the sanctity of human life, and I have a deep respect for my fellow members of the pro-life community and their ongoing efforts in defense of unborn life. Certain provisions that were amended into Am. Sub. HB 493, however, are clearly contrary to the Supreme Court of the United States’ current rulings on abortion.

- Similar legislation enacted in two other states has twice been declared unconstitutional by federal judges, and the Supreme Court declined to review those decisions. Because the federal courts are bound to follow the Supreme Court’s rulings on abortion, the amendment to Am. Sub. HB 493 will be struck down. The State of Ohio will be the losing party in that lawsuit and, as the losing party, the State of Ohio will be forced to pay hundreds of thousands of taxpayer dollars to cover the legal fees for the pro-choice activists’ lawyers. Furthermore, such a defeat invites additional challenges to Ohio’s strong legal protections for unborn life. Therefore, this veto is in the public interest.



### **Appropriation for the Department of Jobs and Family Services for Adoption Services**


This item appropriates an additional \$100,000 from the General Revenue Fund to the Department of Jobs and Family Services (“the Department”) for adoption services. While I strongly support the promotion of adoption and have worked to expand adoption supports and efforts in my Administration, the Department currently has sufficient funds in the current budget for these purposes. Accordingly, additional appropriation for adoption services is not warranted at this time. Therefore, this veto is in the public interest.
