#### **VETO MESSAGE**

## STATEMENT OF THE REASONS FOR THE VETO OF AMENDED SENATE BILL 375

### January 11, 2021

Pursuant to Article II, Section 16, of the Ohio Constitution, which states that the Governor may disapprove of any bill, I hereby disapprove of Amended Senate Bill 375 "To void the Director of Health's order regarding county fairs and create the Agricultural Society Working Group for 2021" and set forth the following reasons for so doing, as it is not in the best interest of protecting the health and safety of all Ohioans.

On July 28, 2020, I announced the difficult decision to limit all fairs to junior fair events and the Order took effect on July 31, 2020. The issuance of the Order was necessary to prevent the spread of COVID-19 while preserving the essence of our fairs --- the many projects that our youth participate in at the fair.

During the 2020 fair season, many county and independent fairs stepped up to the plate. Coordinating with their local health departments, they worked hard to ensure social distancing requirements and mask wearing. However, as I stated in July, the COVID-19 pandemic and the challenges related to it necessitated the Order to limit fairs to junior fair related activities.

My administration and the Legislature worked together during the 2020 fair season to provide some financial relief to the 94 agricultural societies. On June 9, 2020, the Lieutenant Governor and I, along with the Senate President and Speaker of the House, announced the issuance of \$4.7 million to local fairs with \$50,000 for each fair conducting a junior fair in the 2020 season. Additionally, fairs that chose not to operate a junior fair received \$15,000 that can be utilized for the 2021 season. The issuance of the funds was approved by the Controlling Board on June 15, 2020.

Further, in April of 2020, I announced that the Ohio Department of Agriculture had waived the \$50,000 local match requirement for the Agricultural Society Facilities Grant Program (which allows for fairground improvements at their facilities). This decision ensured continued state funding while recognizing the financial hardships to our agricultural societies due to the COVID-19 pandemic.

As the 2021 fair season is set to begin in June, my administration will continue to consult with health professionals on the state and local level. It is imperative that such fairs be conducted in a safe manner that reflect the facts on the ground at the time.

Amended Senate Bill 375 voids the Director of Health's Order that took effect on July 31, 2020. Any modifications to this Order or potential rescinding of this Order must be made in consultation with such health professionals.

As these discussions occur, it is also essential to consult with the General Assembly and the local fair boards throughout Ohio. I look forward to their invaluable input as we anticipate the 2021 fair season. However, a blanket rescission of the current Order does not achieve the goal of working together to properly plan the upcoming fair season while ensuring the public health and protection of the people of Ohio. Therefore, it is reasonable and necessary for the current Order to remain in effect while these collaborative efforts occur.

For these reasons, this veto is in the public interest.

### **ANACT**

To void the Director of Health's July 30th order regarding county fairs and create the Agricultural Society Working Group for 2021.

Be it enacted by the General Assembly of the State of Ohio:

Section 1. The Director of Health's order "Limiting County Fairs to Junior Fair Activities and Animal Exhibitions, with Exceptions" on July 30, 2020, is void.

Section 2. (A) The Agricultural Society Working Group for 2021 is hereby created to study and recommend protocols for the safe and hygienic operation of agricultural society fairs, and for festivals held by other organizations.

- (B) The Working Group shall meet periodically and shall conduct its initial meeting not later than fifteen days after the effective date of this section. The Working Group shall publish initial recommended protocols not later than April 10, 2021. The Working Group may update its recommendations at any time prior to the working group's termination.
  - (C) The Working Group shall include the following members:
- (1) Two members of the Senate appointed by the Senate President, one from the majority party and one from the minority party;
- (2) Two members of the House of Representatives appointed by the Speaker of the House, one from the majority party and one from the minority party;
- (3) One member from the Department of Agriculture, appointed by the Director of Agriculture;
  - (4) One member from the Department of Health, appointed by the Director of Health;
  - (5) One member from the Governor's office, appointed by the Governor;
- (6) One member from the Association of Ohio Health Commissioners, appointed by the Association;
  - (7) One member from the Ohio Farm Bureau, appointed by the Bureau;
  - (8) One member from the Ohio Fair Managers Association, appointed by the Association;
  - (9) One member from the Ohio Expositions Commission, appointed by the Commission;
- (10) One member from the Greater Ohio Showmen's Association, appointed by the Association;
- (11) One member from the Ohio Festivals and Events Association, appointed by the Association;
  - (12) One member from the Ohio Cattlemen's Association, appointed by the Association;
  - (13) One member from the Ohio Poultry Association, appointed by the Association;
  - (14) One member from the Ohio Pork Council, appointed by the Council;

- (15) One member from the Ohio Veterinary Medical Association, appointed by the Association;
- (16) One member from the Ohio Sheep Improvement Association, appointed by the Association;
- (17) One member from the Ohio 4-H Youth Development Program, appointed by the Program;
- (18) One member from the Ohio Association of Agriculture Educators, appointed by the Association;
- (19) Representatives from any other organization added at the discretion of the above listed members, provided that total membership of the working group shall not exceed twenty-five individuals and no organization, except for the Senate and House of Representatives, is represented by more than one individual.
- (D) The Working Group members representing the majority party in the Senate and the majority party in the House of Representatives shall jointly chair the Working Group.
- (E) The Agricultural Society Working Group for 2021 shall cease to exist on February 1, 2022.
