# **Bill Analysis**

### SUMMARY

 Authorizes World War II veterans to obtain WWII license plates without paying motor vehicle registration taxes and fees.

## **DETAILED ANALYSIS**

#### WWII license plates

The bill authorizes a World War II veteran to receive the WWII license plates, which currently exist through the military license plates administrative program, without paying registration taxes and fees.<sup>1</sup> The administrative program includes a variety of military license plates that are designed to recognize a specific military branch, a particular combat zone, or a medal that the veteran was awarded.<sup>2</sup>

#### Exceptions under current law

Generally, military veterans who receive and renew their motor vehicle registrations through the program receive the physical license plates for free (a savings between \$6.50 and \$7.50), but still pay the standard registration taxes and fees.<sup>3</sup> Recently, an exception to paying the registration taxes and fees for military license plates through the program was created for military veterans with a service connected disability rated at 100% by the federal Veterans'

Administration.<sup>4</sup> Such disabled veterans can receive the "Disabled Veterans" license plates without paying registration taxes or fees, as well.<sup>5</sup> Additionally, current law permits a Congressional Medal of Honor recipient, a former prisoner of war, and a Purple Heart recipient to receive license plates reflecting that status or honor without paying registration taxes or fees.<sup>6</sup>
