# **Bill Analysis**

#### **SUMMARY**

- Abolishes or renews various agencies that are subject to expiration under Sunset Review Law.
- Requires a Sunset Review Committee to be convened during each General Assembly, and makes other changes to Sunset Review Law.
- Authorizes the Ohio Judicial Conference to distribute judicial impact statements in an electronic format.

#### **DETAILED ANALYSIS**

#### **Boards and commissions – Sunset Review**

The bill requires that a new Sunset Review Committee be convened to function during each general assembly, thereby providing two biennia to complete the review of agencies under Sunset Review Law. Under current law, a Sunset Review Committee is convened only during each odd-numbered General Assembly. The bill renews certain agencies until the end of 2022 and renews other agencies until the end of 2024. The bill requires the Sunset Review

Committee that is convened during the 134<sup>th</sup> General Assembly to review all agencies that are scheduled to expire on December 31, 2022, and also to select a number of agencies, which are renewed by the bill until December 31, 2024, to be reconsidered for a renewal to expire on December 31, 2026. The Sunset Review Committee of the 134<sup>th</sup> General Assembly, at the Committee's discretion, may recommend that the expiration date of any such agency be renewed until December 31, 2026, without further review, or may require the agency to submit to the requirements of Sunset Review Law. The bill clarifies that the intent of these requirements is to establish that, at the conclusion of the 134<sup>th</sup> General Assembly, approximately ½ of all agencies subject to Sunset Review Law will be scheduled to expire on December 31, 2024, and approximately ½ will be scheduled to expire on December 31, 2024.

The bill maintains the current appointment and membership requirements of the Committee. And maintains provisions of Sunset Review Law that provide that if the General Assembly does not renew or transfer a state "agency" (see "**Definition of agency**," below) before the agency's scheduled expiration date, the agency expires and the Office of Budget and Management cannot authorize the expenditure of any money for the agency on or after the expiration date.<sup>2</sup>

#### Agency expiration schedule

The bill enumerates the intent of the General Assembly for an agency to expire by operation of Sunset Review Law four years more or less after the effective date of the act that established the agency, and that the specific expiration date, for an agency scheduled to expire, must be December 31 in the second year of a general assembly. Under the bill, agencies will expire, unless renewed, according to the following:

- 1. An agency created during an even-numbered general assembly expires at the end of the second year of the next odd-numbered general assembly;
- 2. An agency created during an odd-numbered general assembly expires at the end of the second year of the next even-numbered general assembly;
- 3. An agency renewed by a prior Sunset Review Committee expires on the expiration date specified in the act that renewed the agency.

### **Definition of agency**

Under continuing law, the Sunset Review Law applies to an "agency," which generally means any board, commission, committee, or council, or any other similar state public body required to be established under state statutes for the exercise of any function of state government and to which members are appointed or elected. However, the definition specifies several exceptions to the general rule, including, for example, the General Assembly, any court, any public body created by or directly under the Ohio Constitution, the Public Utilities

Commission of Ohio, any state board or commission that has the authority to issue any final adjudicatory order that may be appealed to the court of common pleas under the Administrative Procedure Act.<sup>3</sup>

## **Abolition of specific agencies**

Under continuing law, "abolish" means to repeal the statutes creating and empowering an agency, remove its personnel, and transfer its records to the Department of Administrative Services under the State Records Program Law.<sup>4</sup> The bill abolishes the agencies listed below:<sup>5</sup>

## Renewal of specific agencies

Under continuing law, "renew" means to continue an agency, and may include amendment of the statutes creating and empowering it, or recommendations for changes in its operation or personnel.<sup>6</sup> The bill renews certain agencies as listed below and specifies that they will expire on December 31, 2022, or December 31, 2024, unless they are again renewed by subsequent legislation:

## **Ohio Family Stability Commission**

The bill renews the Ohio Family Stability Commission with respect to Sunset Review Law. However, pursuant to its enabling legislation, the Commission is set to expire at the end of March 31, 2021.9

#### **Ohio Judicial Conference**

The bill authorizes the Ohio judicial conference to distribute judicial impact statements, which are required to be prepared under current law, in an electronic format, to the official

electronic mail address of the General Assembly members designated to receive the statement.<sup>10</sup> And, the bill renews the Ohio Judicial Conference until December 31, 2024.<sup>11</sup>

### Other changes to Sunset Review Law

The bill makes the following changes to Sunset Review Law:

- Eliminates the authorization for the Sunset Review Committee to schedule for review any state board or commission that has the authority to issue any final adjudicatory order that may be appealed to the court of common pleas. Such agencies, which are generally occupational licensing agencies, are currently exempt from automatic sunset, but may be scheduled for review by a Sunset Review Committee. Recently enacted legislation subjects occupational licensing agencies to a different legislative review process.¹²
- Eliminates the requirement that a Sunset Review Committee, whenever possible, realign agency titles to conform to certain specified descriptions for the terms commission, authority, board, council, and committee.<sup>13</sup>
- Eliminates the requirement that the Director of the Legislative Service Commission publish, in the Administrative Code, a copy of the Sunset Review Committee schedule for review of agencies. Continuing law requires the schedule to be published in the Register of Ohio.<sup>14</sup>
- Relocates within the Revised Code a provision specifying that a Sunset Review Committee, after having prepared and published a report of its findings and recommendations, and furnished the report, ceases to exist.<sup>15</sup>
