5.2528 _____ To enact section ~~5.2522~~ of the Revised Code to designate the second week of November as "Ohio Diabetes Awareness-Heart Connection Week."

Be it enacted by the General Assembly of the State of Ohio:

5.2528 _____ SECTION 1. That section ~~5.2522~~ of the Revised Code be enacted to read as follows:

5.2528 _____ Sec. ~~5.2522~~. The second week of November is designated as "Ohio Diabetes Awareness-Heart Connection Week" to raise awareness of the diabetes epidemic in this state and the connection between diabetes and cardiovascular disease.

The section numbering of law of a general and permanent nature is complete and in conformity with the Revised Code. *


