Highlights

- The bill makes capital appropriations totaling \$2.00 billion for the FY 2025-FY 2026 biennium. Of this amount, \$1.65 billion is supported by debt and \$0.35 billion is supported by cash. These appropriations are summarized in the following table.

School Building Program Assistance Fund (Fund 7032)

The bill appropriates \$600.0 million under Fund 7032 ALI C23002, School Building Program Assistance, to provide the state share of project costs to school districts participating in facilities projects overseen by OFCC. Most of OFCC's school facilities appropriations are provided to districts through the Classroom Facilities Assistance Program (CFAP). State funding under CFAP is provided as a percentage of a district's "basic project cost" to address the entire classroom facilities needs of the district. All school districts are eligible for CFAP. However, the state share of a district's basic project cost is based on each district's relative wealth. Lower wealth districts are funded before higher wealth districts and receive a larger percentage of their total project funding from the state. A school district generally passes a bond levy to meet its required local share to participate in CFAP. The bill authorizes the Ohio Public Facilities Commission (OPFC) to issue and sell \$600.0 million in new bonds deposited to the credit of Fund 7032 to support the appropriation from ALI C23002.

State Capital Improvements Fund (Fund 7038)

The bill appropriates \$400.0 million under Fund 7038 ALI C15000, Local Public Infrastructure/State CIP, for PWC to issue grants to local governments for road and bridge projects, fresh water treatment and distribution systems, wastewater collection and treatment facilities, storm sewer systems, and solid waste disposal facilities under the State Capital Improvement Program (SCIP). The bill authorizes OPFC to issue and sell \$400.0 million in new bonds deposited to the credit of Fund 7038 to support the appropriation from ALI C15000.

Higher Education Improvement Fund (Fund 7034)

The bill appropriates a total of \$397.6 million under Fund 7034 to support construction of new facilities, major renovations of existing facilities, or basic renovations at public universities and their regional campuses and community colleges. The table below summarizes the total capital appropriations that each university or community college receives from Fund 7034 under the bill. The bill also authorizes OPFC to issue and sell \$397.0 million in new bonds deposited to the credit of Fund 7034 and the Higher Education Improvement Taxable Fund (Fund 7024) to support all of the appropriations supported under Fund 7034.

Adult Correctional Building Fund (Fund 7027)

The bill appropriates \$100.0 million under Fund 7027 ALI C501HK, Large Local Jail Facility Funding Program, and \$150.0 million under Fund 7027 ALI C501HL, Local Jail Facility Funding Program, to support the Large Local Jail Facility Funding and the Local Jail Facility Funding programs, respectively, under the budget of DRC.

Under the Local Jail Facility Funding Program, DRC is authorized to provide grants for local jail construction and renovation projects pursuant to a funding formula that ranks counties based on taxable property value and taxable retail sales as determined by the Department of Taxation. DRC invites applications from a number of the lowest ranking counties. Qualifying applicants are awarded a grant for a percentage of their total project cost, based on the applicant's ranking, but at least 25%. This program is similar to one temporarily enacted in H.B. 33 of the 135th General Assembly that is scheduled to sunset at the end of FY 2024.

The bill also creates the Large Local Jail Facility Funding Program under which higher ranking counties may apply for assistance. For all qualifying applicants under this program, DRC is to first fund 25% of the project cost for the lowest ranking applicant, then 25% for the next lowest ranking applicant, and so on to the extent funding is available. If an applicant receives less than 25% of the project cost in a given year due to lack of funding, that applicant is given priority for funding in the next year.

The bill authorizes the Treasurer of State to issue and sell \$250.0 million in new bonds deposited to the credit of Fund 7027 to support the appropriations from ALIs C501HK and C501HL.

One Time Strategic Community Investments Fund (Fund 5AY1)

The bill appropriates \$350.0 million from Fund 5AY1 to ALI C04200, One Time Strategic Community Investments, in the budget of the Office of Budget and Management (OBM). Fund 5AY1 received a transfer of \$700.0 million from the GRF at the beginning of FY 2024 under a provision of H.B. 33 of the 135th General Assembly, the main operating appropriations bill. As of this writing, no appropriations have been made out of the fund. The bill earmarks the appropriation for the projects listed in the following table.
