## State and Local Fiscal Analysis

#### New capital appropriation

The bill appropriates \$200,000 in capital funds from the Cultural and Sports Facilities Building Fund (Fund 7030) appropriation item C230X4, Stranahan Theater and Great Hall Toledo, under the Facilities Construction Commission, for the FY 2017-FY 2018 biennium.

### **Capital reappropriations**

The bill reappropriates approximately \$1.48 billion in capital funds for the FY 2017-FY 2018 biennium. This amount represents an estimate of available moneys on July 1, 2016. Generally, the actual reappropriations will be equal to the actual moneys available on July 1, 2016. These capital reappropriations are summarized in the two tables below. Table 1 presents the estimated amounts by fund. Table 2 presents the estimated amounts by fund and agency.
