## BILL SUMMARY

- Allows a public school district or private school to establish a license plate for that district or school.
- Establishes procedures for termination and reestablishment of the license plates.


## CONTENT AND OPERATION

## School license plate programs

The bill creates two license plate programs that allow individual public school districts and individual private schools in Ohio to establish and design special license plates with the name of the district or school on them. The programs allow for the creation of the individualized school plates without the need for additional legislation for each public school district or private school. ${ }^{1}$ These programs are modeled on the Collegiate License Plate Program, which is established in current law. ${ }^{2}$

The following chart summarizes both license plate programs:

## Registrar requirements

The Registrar must adopt rules to efficiently administer the Public School District and Private School License Plate Programs. Additionally, the Registrar must establish procedures for the participation in the respective Programs by individual public school districts and individual private schools. ${ }^{7}$

## Termination procedures

The bill creates a procedure for terminating an individual public school district license plate or individual private school license plate that is created pursuant to the bill. During any calendar year, if the number of motor vehicle registrations, including new registrations and registration renewals, totals less than 150 registrations for an individual license plate, the Registrar may terminate the license plate designed by that public school district or private school. ${ }^{8}$

The Registrar must provide written notice between January 1 and January 15 to the public school district or the private school whose license plate is being terminated. The notice must include a statement that the license plate is being terminated as of the date of the notice, that no new applications for issuance of the license plate will be accepted, that no registration renewals for the license plate will be accepted unless the currently owned license plates remain serviceable, and information about the reestablishment procedures for terminated license plates. ${ }^{9}$

If the license plates remain serviceable, registration renewals will continue to be accepted and the contribution will continue to go to the respective public school district or private school, even after the termination of the license plate. However, if the license

[^1]plates are not serviceable and there is no remaining stock of the particular public school district's or private school's license plate, the Register must deny the motor vehicle owner's application for that particular special license plate. ${ }^{10}$

## Reestablishment procedures

The bill also creates a procedure for reestablishing any individual public school district license plate or individual private school license plate that is terminated under the termination procedures specified above. If a particular public school district or private school wants to reestablish their license plate, it must gather written statements from at least 150 people. The written statements must indicate that those people intend to apply for and obtain that particular license plate for their motor vehicles. The Registrar may require the statement to be on a particular form provided by the Registrar. In determining whether 150 people intend to purchase the special license plates, the Registrar must include in the total the number of motor vehicles that continue to display the license plate that has been terminated. ${ }^{11}$
