### CONTENT AND OPERATION

#### "Ohio National Guard Ohio Cross" license plate

The bill creates the following license plate:<sup>1</sup>

Special License Plate	Ohio National Guard Ohio Cross license plate, which contains an illustration of the Ohio National Guard Ohio Cross and is inscribed with the words "Ohio Cross Medal Recipient."
Recipients	Available to any person who has been awarded the Ohio National Guard Ohio Cross medal.
Eligible Vehicles	Any passenger car, noncommercial motor vehicle, recreational vehicle, or other vehicle approved by the Registrar of Motor Vehicles.
Contribution, Additional BMV Fee, and Use of Contribution	None.
Requirements for Issuance	<ul> <li>(1) Submission of an application;</li> <li>(2) Documentary evidence of receipt of the award, as required by the Registrar;</li> <li>(3) Payment of the regular license tax, any local tax, contribution, administrative fee, any special reserved license plate fee if necessary; and</li> <li>(4) Compliance with all other relevant laws relating to motor vehicle registration.</li> </ul>

Combined with Special Reserved License Plate	May be combined with a special reserved license plate provided in current law.
Applicability of License Plate Termination Procedures	Procedures governing the termination of nonstandard license plates do not apply. <sup>2</sup>

## "Ottawa National Wildlife Refuge" license plate

The bill creates the following license plate:<sup>3</sup>

Special License Plate	<b>Ottawa National Wildlife Refuge</b> license plate, which is inscribed with identifying words or markings that are designed by representatives of the Ottawa National Wildlife Refuge and that are approved by the Registrar of Motor Vehicles.
Recipients	Available to all applicants.
Eligible Vehicles	Any passenger car, noncommercial motor vehicle, recreational vehicle, or other vehicle approved by the Registrar.
Contribution, Additional BMV Fee, and Use of Contribution	<ul> <li>\$20 contribution to be used by the Ottawa National Wildlife Refuge for wildlife preservation purposes.<sup>4</sup></li> <li>\$10 additional administrative BMV fee.</li> </ul>
Requirements for Issuance	<ul> <li>(1) Submission of an application;</li> <li>(2) Payment of the regular license tax, any local tax, contribution, administrative fee, any special reserved license plate fee if necessary; and</li> <li>(3) Compliance with all other relevant laws relating to motor vehicle registration.</li> </ul>
Combined with Special Reserved License Plate	May be combined with a special reserved license plate provided in current law.
Applicability of License Plate Termination Procedures	Procedures governing the termination of nonstandard license plates apply. <sup>5</sup>
