132nd General Assembly (H. Criminal Justice)

This table summarizes how the latest substitute version of the bill differs from the immediately preceding version. It addresses only the topics on which the two versions differ substantively. It does not list topics on which the two bills are substantively the same.

Торіс	Previous Version (L-132-0252-1)	Sub. Version (L-132-0252-3)
Voyeurism	Expands the offense of voyeurism to prohibit some of the proscribed acts when they involve an impaired person (<i>R.C. 2907.08(C)</i>).	No provision.
Felony sentencing for certain sex offenses involving an impaired person	For the following offenses, imposes the same penalties for commission of each offense involving an impaired person as the penalties that currently apply to commission of each offense involving a minor: pandering obscenity involving a minor, pandering sexually oriented matter involving a minor, and illegal use of a minor in a nudity-oriented material or performance, and renames each offense to include reference to impaired persons (<i>R.C.</i> 2907.321(<i>C</i>), 2907.322(<i>C</i>), 2907.323(<i>B</i>)).	Reduces the penalty for pandering obscenity involving a minor or impaired person, pandering sexually oriented matter involving a minor or impaired person, and illegal use of a minor or impaired person in a nudity-oriented material or performance when each of those offenses involves an impaired person from a second degree felony to a third degree felony (<i>R.C.</i> 2907.321(<i>C</i>), 2907.322(<i>C</i>), 2907.323(<i>B</i>)).
	No provision.	Increases the maximum prison term for a third degree felony violation of pandering obscenity

Торіс	Previous Version (L-132-0252-1)	Sub. Version (L-132-0252-3)
		involving a minor or impaired person, pandering sexually oriented matter involving a minor or impaired person, and illegal use of a minor or impaired person in a nudity-oriented material or performance from three years to five years (increased maximum penalty only applies if offense involves an impaired person) (<i>R.C.</i> 2929.14(A)(3)(a)).
Mandatory prison term	Requires a mandatory prison term for the offense of illegal use of a minor or impaired person in a nudity-oriented material or performance if the offender is also convicted of a specification that the offense was committed in furtherance of human trafficking (<i>R.C.</i> 2929.13(<i>F</i>)(16)).	Requires a mandatory prison term for the offense of illegal use of a minor or impaired person in a nudity-oriented material or performance if the offender is also convicted of a specification that the offense was committed in furtherance of human trafficking and the offense involves a minor (mandatory prison term not required if offense involves an impaired person) (<i>R.C.</i> 2929. $13(F)(16)$).
