Subject: "Lions Club" license plate

State & Local Fiscal Highlights

- Annually, license plate production costs will total up to \$1,000 or more and the related administrative fees collected will total up to \$1,500 or more. The administrative fees will be deposited into the existing Public Safety Highway Purposes Fund (Fund 5TM0), which the Bureau of Motor Vehicles uses to defray the cost of manufacturing and distributing license plates and stickers, and to cover the cost of motor vehicle registration.
- Up to \$2,250 or more will be generated annually for distribution to the Ohio Lions Foundation. If all of the nearly 15,000 Ohio Lions Club members purchase license plates, then the amount generated for distribution could be as much as \$225,000 per year.
- The actual magnitude of the revenues and expenditures noted in the preceding dot points are dependent upon demand for the license plate, which is uncertain.
- The bill will have no direct fiscal effect on political subdivisions.

Detailed Fiscal Analysis

"Lions Club" license plate

The bill creates the "Lions Club" license plate that is available to all Ohio motorists. As summarized in Table 1 below, a motorist applying for the plate must pay: (1) a \$10 Bureau of Motor Vehicles (BMV) administrative fee, and (2) a \$15 contribution to be used by the Ohio Lions Foundation. The bill will have no direct fiscal effect on political subdivisions.

License plate implementation and termination procedures

Under existing law, a special license plate generally is subject to a minimum registration requirement and to related termination and revival procedures. For example, the BMV Registrar is not required to implement any legislation that creates a new license plate until the Registrar receives written statements from at least 150 persons indicating that they intend to apply for and obtain the special license plate (R.C. 4503.78). If, during any calendar year, the total number of new and renewal motor vehicle registrations involving a license plate totals less than 25, the issuance of that license plate may cease as of December 31 of the following year (R.C. 4503.77).

Production costs and administrative fees

The BMV currently produces special license plates via a digital print-on-demand process. The total cost to produce a pair of these plates is \$6.08. Under the bill, a person obtaining a "Lions Club" license plate must pay an administrative fee of \$10, the purpose of which is to compensate the BMV for additional services required in issuing the plate. The administrative fees will be credited to the existing Public Safety – Highway Purposes Fund (Fund 5TM0),¹ which is used in part to pay the BMV's expenses related to titling motor vehicles, licensing drivers, and registering motor vehicles.

Ohio Lions Foundation

The \$15 contribution paid for the issuance of the "Lions Club" license plate will be credited to the existing License Plate Contribution Fund (Fund 5V10) and then paid to the Ohio Lions Foundation to be used for charitable and educational purposes. The demand for this license plate is uncertain, but presumably many of the applicants will be members of the Ohio Lions Club. The Club's website states that it has nearly 15,000 members.

Estimated annual revenues and expenditures

Table 2 below shows three different estimates of the annual revenues and expenditures that could be generated by the issuance of "Lions Club" license plates based on: (1) the statutory requirement that at least 25 motorists need to apply for or renew the plate each year to ensure the plate's availability, (2) the statutory requirement that at least 150 motorists need to indicate that they intend to apply for and obtain the plate if the BMV Registrar is to make the plate initially available, and (3) nearly all of the Ohio Lions Club members applying for the plate.

¹ The Public Safety – Highway Purposes Fund (Fund 5TM0) was created in H.B. 26 of the 132nd General Assembly to consolidate the existing State Bureau of Motor Vehicles Fund (Fund 4W40), State Highway Safety Fund (Fund 7036), Highway Safety Salvage and Exchange Administration Fund (Fund 8300), and Highway Safety Salvage and Exchange Highway Patrol Fund (Fund 8410). Fund 5TM0 became effective on July 1, 2017.
