## CONTENT AND OPERATION

## "North Royalton City Schools" license plate

The bill creates the following license plate: ${ }^{1}$

| Special License Plate | North Royalton City Schools license plate, inscribed with <br> the words and markings selected and designed by the <br> North Royalton City School District and that are approved <br> by the Registrar of Motor Vehicles. |
| :--- | :--- |
| Recipients | Available to all applicants. |
| Eligible Vehicles | Any passenger car, noncommercial motor vehicle, <br> recreational vehicle, motorcycle, cab-enclosed motorcycle, <br> motor-driven cycle, or other vehicle approved by the <br> Registrar. |
| Contribution and Additional <br> BMV Fee | \$30 required contribution. <br> \$10 additional administrative BMV fee. |
| Use of Contribution | Contributions must be used by the North Royalton City <br> School District to provide services to the school district's <br> students that assist in developing or maintaining the mental <br> and emotional well-being of the students. |
|  | The services may include bereavement counseling, <br> instruction in defensive driving techniques, sensitivity <br> training, and the counseling and education of students <br> regarding bullying, dating violence, drug abuse, suicide <br> prevention, and human trafficking. |

[^0]|  | The school district may hire charitable (501(c)(3)) <br> organizations to provide services or may pay for faculty <br> members to receive training in providing the services. |
| :--- | :--- |
|  | The school district is prohibited from using the contributions <br> it receives for any purpose other than providing the <br> services specified above. |
| Requirements for Issuance | (1) Submission of an application; |
|  | (2) Payment of the regular license tax, contribution, <br> administrative fee, any applicable local tax, any applicable <br> special reserved license plate fee; |
| Combined with Special | (3) Compliance with all other applicable laws relating to <br> motor vehicle registration. |
| Reserved License Plate | May be combined with a special reserved license plate <br> provided in current law. |
| Applicability of License Plate | Procedures governing the termination of nonstandard <br> license plates do not apply. |
| Termination Procedures | Requires the school district to produce and submit an <br> annual report to the Department of Mental Health regarding <br> the amount received in contributions, an itemized list of <br> expenditures, and the total percentage of spending used to <br> provide services to students that assist in developing and <br> maintaining mental and emotional well-being. Failure to <br> submit the report will result in the contributions being <br> redirected to the GRF. |
