## H.B. 484

132nd General Assembly (H. State & Local Government)

This table summarizes how the latest substitute version of the bill differs from the immediately preceding version. It addresses only the topics on which the two versions differ substantively. It does not list topics on which the two bills are substantively the same.

Торіс	Previous Version (As Introduced)	Sub. Version (L_132_1851-2)
Health district naming	No provision.	Allows a health district to identify itself as a health district, health department, department of health, or a name including the term "public health." ( <i>R.C. 3709.01.</i> )
Credit card policy	No provision.	Requires a board of health to adopt a policy regarding the use of credit cards which must include specified provisions. (R.C. 3709.42(A).)
Criminal offense	Specifies misuse of a credit card with purpose to defraud is a criminal offense. ( <i>R.C.</i> 3709.42( <i>D</i> ))	Specifies knowing misuse of a credit card is a criminal offense. (R.C. 3709.42(F).)
Name on credit card	No provision.	Requires the name of the health district to appear on each credit card or check. (R.C. 3709.42(B).)
Liability	Makes a credit card user personally liable for unauthorized use of a credit card and up to \$50 for failing to notify the board of the loss, theft, or unauthorized use of a credit card. ( <i>R.C.</i> 3709.42( <i>C</i> ).)	Makes a credit card user personally liable for amounts the user charged to a signed-out credit card and does not provide itemized receipts. (R.C. 3709.42(E).)

Торіс	Previous Version (As Introduced)	Sub. Version (L_132_1851-2)
Compliance officer	No provision.	In some cases, requires the appointment of a compliance officer. ( <i>R.C. 3709.42(C).)</i>
Quarterly review	No provision.	Requires the board and compliance officer to review credit cards quarterly. (R.C. 3709.42(D).)
Sign out system	No provision.	Specifies the district custodian of health funds may use a system to sign out cards to authorized users. (R.C. 3709.42(E).)
Rewards reporting	No provision.	Requires the district custodian to file an annual report with the board detailing credit card rewards. (R.C. 3709.42(G).)
Credit card payment	Specifies debt incurred by use of a credit card must be paid from money appropriated by the board for the expenses. ( <i>R.C.</i> 3709.42(A).)	No provision.
Credit card definition	No provision.	Defines credit card to mean any bank-issued credit card account, store-issued credit card account, financial institution-issued credit card account, financial depository-issued credit card account, affinity credit card account, or any other card account allowing the holder to purchase goods or services on credit or to transact with the account, and any debit or gift card account related to the receipt of grant moneys; excludes a procurement card account, gasoline or telephone credit card account, or any other card account where merchant category codes are in place as a system of control for use of the card account. ( <i>R.C. 3709.42(H).</i> )
